### FOOT AND MOUTH DISEASE CONTROL

WHEREAS, Foot and Mouth Disease outbreaks would devastate the beef cattle industry in the U.S., the largest agricultural industry in the U.S., and

WHEREAS, the control and prevention of FMD will require a multi-faceted approach,

THEREFORE BE IT RESOLVED, that the OCA places a high priority on the development and storage of improved and validated FMD vaccines, including funding for production and storage of the vaccines.

### CHRONIC WASTING DISEASE ERADICATION AND TUBERCULOSIS

WHEREAS, incidences of Chronic Wasting Disease (CWD) and Tuberculosis (TB) appear to be increasing in frequency and distribution, and

WHEREAS, there is a marked increase in the population of wild and farmed cervidae over most of the United States, and

WHEREAS, there are documented cases of beef cattle contracting TB from cervidae, and

WHEREAS, CWD and TB have become a very serious disease in farmed cervidae (elk, mule deer and white tailed deer, etc)

THEREFORE BE IT RESOLVED, that the OCA strongly supports USDA-ARS and University research on CWD and TB,

BE IT FURTHER RESOLVED, that the OCA requests and supports research efforts to develop more accurate rapid antemortem and postmortem diagnostics; determine route(s) of transmission, including the role of environmental contamination and methods to control CWD and TB, such as genetic resistance,

BE IT FURTHER RESOLVED, that the OCA requests expanded efforts to stop the spread of CWD and TB in cervidae by depopulation of free roaming and farmed cervidae in areas with involved and threatened herds,

BE IT FURTHER RESOLVED, that the OCA supports and encourages the control of transport of live deer and elk or carcasses from areas having CWD and TB,

BE IT FURTHER RESOLVED, that the OCA supports uniform and effective monitoring of interstate and intrastate movement of wild and farmed cervidae,

BE IT FURTHER RESOLVED, that the OCA recommends intensive monitoring of all captive and wild cervidae herds in CWD and TB endemic areas as well as the monitoring of wild cervidae in areas adjacent to facilities of captive cervidae, which have had a diagnosis of CWD or TB,

BE IT FURTHER RESOLVED, that the OCA, in cooperation with NCBA, requests USDA-ARS develop and maintain a current fact sheet on scientific facts about CWD and TB and that this information be widely disseminated to affected parties, i.e., all state veterinarians, USAHA, OCA, state cattle producer associations, state wildlife agencies and the Department of the Interior.

WHEREAS, adequate state and federal funding of existing indemnity programs, in the event of widespread catastrophic occurrences, is uncertain and unrealistic to depend on, and

WHEREAS, there is no readily available or affordable private sector or governmental financial capacity to fund response to catastrophic events, and

WHEREAS, in the absence of a comprehensive catastrophic livestock risk insurance for such catastrophic risks,

THEREFORE BE IT RESOLVED, that the OCA encourages the federal government to provide the same reinsurance and funding as provided to the FCIC (Federal Crop Insurance) Program.

## OKLAHOMA PHOSPHORUS ISSUE

WHEREAS, any source of phosphorus when properly managed, will not negatively impact surface water quality in the State of Oklahoma, and

WHEREAS, the development of Nutrient Management Plans for concentrated animal feeding operations should be based on current research and sound science available to nutrient management planners and CAFO operators, and

WHEREAS, Nutrient Management Plans should include considerations for both nitrogen and phosphorus when animal manure is beneficially used on farmland and rangeland,

WHEREAS, the climatic conditions, topography and soil characteristics vary significantly across the state of Oklahoma from west to east and north to south,

THEREFORE BE IT RESOLVED, that the OCA believes additional science is needed within the state of Oklahoma to recognize regional differences in phosphorus source and transparent characteristics for land application fields, and

BE IT FURTHER RESOLVED, the Phosphorus Index, developed by NRCS should be available to CAFO operators as a tool to conduct a site specific assessment for phosphorus based on source and transport characteristics. Pre-defined limits should not be established that would arbitrarily cap phosphorus application on any field, whether located within a nutrient limited watershed or not.

BE IT FURTHER RESOLVED, that when exercising eminent domain, agencies must limit the scope of the acquisition to the actual needs of the project and excess property must be returned to the original landowner at the original price paid to said landowner.

# McGIRT v. OKLAHOMA

WHEREAS the Supreme Court of the United States (SCOTUS) ruled in *McGirt v. Oklahoma;* 591 U.S. (2020) that Congress failed to disestablish the Muskogee Creek Nation in the Oklahoma Enabling Act and other Allotment Era legislation; and

WHEREAS questions have arisen as to whether the SCOTUS ruling in *McGirt* was limited to the scope of the Major Crimes Act (MCA) creating uncertainty for the State of Oklahoma's authority over any area that touches Indian affairs ranging from zoning and taxation to family law and environmental law; and

WHEREAS *McGirt* has destabilized the long-established governance of eastern Oklahoma, and has the potential to cause similar disruptions in other Indian country jurisdictions including the interruption of law enforcement and prosecution; and

WHEREAS, a century of practice prior to *McGirt* presumed that the Five Civilized Tribe's prior reservations were extinguished, and the State of Oklahoma has maintained unquestioned jurisdiction over such lands since statehood; and

WHEREAS, Oklahoma Cattlemen's Association members support consistent and uniform laws relative to the business of cattle raising.

THEREFORE BE IT RESOLVED, the OCA supports any judicial re-interpretation which overturns or limits the scope of the *McGirt* decision; and

BE IT FURTHER RESOVED, the OCA supports clarification of the intent of Congress to disestablish the reservations of the Five Civilized Tribe's reservations; and

BE IT FURTHER RESOLVED, OCA supports any measure which will normalize the criminal and civil jurisdiction of the State of Oklahoma and its political subdivisions as understood prior to the *McGirt* decision; and

BE IT FURTHER RESOLVED, OCA encourages the state of Oklahoma and tribal governments to adopt uniform laws relating to livestock, including, but not limited to, cattle theft, animal disease, animal identification, estray recovery, etc. to ensure uniform application of such laws statewide.

- Moving the tax exemption status of producing marijuana out of the agriculture sales tax exemption code to a different or new code.
- Modifying the process of recovering abandoned land from marijuana grow facilities so the land is in productive ownership quickly, efficiently and fairly.

WHEREAS, this type of tribal sovereignty claim could potentially be made in any part of historic Indian Territory which encompasses all of Oklahoma except for the panhandle;

THEREFORE, BE IT RESOLVED, the OCA opposes any tribe's efforts to extend their reservation status or sovereignty to non-tribal lands or people, and

BE IT FURTHER RESOLVED, the OCA urges our elected state and federal representatives to safeguard the civil, legal, and property rights of all Oklahomans, and to ensure that these rights are protected under state and federal law by their duly elected government and courts.

WHEREAS, it is critical for cattle producers to lead the sustainability discussion so that beef sustainability programs are developed by cattlemen for cattlemen.

THEREFORE BE IT RESOLVED, OCA shall join the U.S. Roundtable for Sustainable Beef as a member and cooperate with NCBA to lead and expand sustainability research, education and policy initiatives to protect the interests of Oklahoma cattle producers.

## MARKET TRANSPARENCY

WHEREAS transparency in cattle markets is defined as broad access to critical information such as price (including but not limited to base price), weight, delivery date, location and any other data that reveals the value of cattle as expressed by an open and competitive market; and

WHEREAS there are currently many live cattle transactions (such as but not limited to captive supply, forward contracts, alternative marketing agreements (AMA's), etc.) that are not reported; and

WHEREAS Mandatory Price Reporting (MPR) was created to provide valuable information in an effort to make transparency in the market place more robust; and

WHEREAS there is opportunity upcoming for MPR to be renewed with modifications and thus create more robust transparency in the cattle and beef market place.

THEREFORE BE IT RESOLVED OCA supports the following modifications to MPR:

- Decreasing the reporting window to allow more real time price data
- Broadening the requirements for reporting of non-negotiated traded cattle in an effort to publish and make available more data such as base price, premiums, AMA's, etc..
- Mechanisms such as a contract library or other innovations that will help achieve more price transparency in the live cattle market.

## TRANSPARENCY IN PACKER CAPTIVE SUPPLY

WHEREAS packer captive supply is defined as cattle that are committed to a specific packer two weeks or more in advance of slaughter with the three most common captive supply methods being alternative marketing/purchasing agreements, forward contracts, and packer feeding and/or financing cattle; and

WHEREAS there is little to no price transparency on captive supply cattle yet there is a significant number of cattle marketed with this method.

THEREFORE BE IT RESOLVED for all packing entities larger than 1,500 head per week, OCA supports the following modifications to price reporting relative to contracts and marketing agreements:

- 1. All contracts and marketing agreements must be reported to USDA within 14 days of setting the contract/marketing agreement and include the following information to be reported should include:
  - a. Number of head
  - b. Base price and how it was determined
  - c. Any additional price adjustment/allowances (if applicable)
  - d. Premium/discount price formulas (if applicable)
  - e. Expected delivery date
- 2. All contracts and marketing agreements must be reported terminated within 7 days post delivery and include the following information:
  - a. Number of head
  - b. Price paid including base price, premiums/discounts and/or additional price adjustments/allowances

## **INCREASE PRICE DISCOVERY - LIVE CATTLE NEGOTIATED TRADE MINIMUMS**

WHEREAS the percentage of live cattle in negotiated cash transactions has declined over time; and

WHEREAS longstanding OCA policy has reflected industry efforts to address industry challenges before seeking government involvement.

THEREFORE BE IT RESOLVED OCA will work vigorously to strengthen price discovery in the live cattle market through industry cooperation efforts and strategies.

THEREFORE BE IT FURTHER RESOLVED if government policies, including legislative and regulatory intervention are established to set negotiated trade minimums, they must target packer captive supply cattle first and foremost.

THEREFORE BE IT FURTHER RESOLVED OCA supports any and all government intervention policies to include a sunset or renewal process so that an off ramp is available should the policy be detrimental and/or the industry develop internal processes/strategies that provide price discovery.
